



# Nature Murals Competition 2019

## Terms and Conditions

*Updated 5<sup>th</sup> December 2018*

### **Terms and Conditions are as follows:**

1. Information on how to enter and all details on the competition form part of these Terms. To the extent of any inconsistency, the Terms below prevail. By entering, participants accept these Terms.
2. Entry is open to NZ Residents only. Anyone employed by (and any immediate family member of someone employed by) Keep New Zealand Beautiful, all sponsors and associates of Keep New Zealand Beautiful and any agencies associated with these companies or with the promotion are ineligible to enter.
3. KNZB are calling for submissions to paint a mural in the community that has environmental messaging. Artists need to develop an original idea that will visually enhance their local community.
4. Design entries must be submitted to the KNZB website by March 28<sup>th</sup> 2019. Please note KNZB has funding to complete between 10 murals. Winners will be notified by April 11<sup>th</sup> 2019.
5. Murals must have the Resene and KNZB logos provided on/near the mural. We will provide the artist with logo stickers that, as well as the mural can be covered with Resene graffiti guard purchased with your Resene vouchers.
6. No spray paint is to be used in creating any Nature Mural.
7. An estimated completion date must be agreed to by both parties.
8. Prizes, payments and winners. There will be 10 winning submissions selected. The judges' decision is final and no correspondence will be entered into.
9. Prize cannot be exchanged for credit or service and no exchange communications will be entered into. Winners will receive the \$750 of Resene vouchers for the creation of their design within their local community, along with high-vis vests, Paint NZ Beautiful t-shirts and M&M test pots. Artist will be paid \$1,000 on completion of the mural with photo evidence of the final completed mural and process of completion.
10. All entries must be submitted for walls that are part of a public space or at least highly visible to the public and not on a residential property.
11. Judging Criteria of the most suitable projects will be based on the following criteria:



- Permission to paint on wall granted
  - Environmental messaging
  - Artists availability and agreement to complete within given timeframes
  - Originality
  - Creativity
  - Enhancement/visual improvement that the project would make to beautify the community
12. The winners will be notified by phone or email.
  13. Health and Safety must be adhered to at all times and creation of winning designs must be done so legally by winners, or as organised by winners fitting with correct Health and Safety procedures and supervised at all times.
  14. Neither Keep New Zealand Beautiful or associated Sponsors are liable for any loss, damage or injury (including without limitation indirect or consequential loss) suffered by any person in connection with the promotion or any prize, except for any liability under the Consumer Guarantees Act 1993 or other liability that cannot be excluded by law.
  15. All entries are deemed received at the time of receipt by Keep New Zealand Beautiful and NOT at time of transmission by the entrant. Keep New Zealand Beautiful's records are conclusive as to time of receipt. Late, lost, stolen, misdirected, illegal, incomplete, illegible, damaged, reproduced, or altered entries are invalid. Keep New Zealand Beautiful is not responsible for such entries or for any error, technical malfunction, loss, omission, communications delay or failure.
  16. Keep New Zealand Beautiful reserves the right to vary these Terms or to modify, suspend, terminate or cancel the promotion.
  17. KNZB reserves the right to verify the validity of any entry. Keep New Zealand Beautiful may disqualify any person(s) who enters the competition with the same email entry as another participant or existing work not created by themselves.
  18. Entries become the property of Keep New Zealand Beautiful. In accordance with the Privacy Act 1993, Keep New Zealand Beautiful collects and holds personal information to conduct the promotion, notify prize winners, verify prize winners' identities and may be used for Keep New Zealand Beautiful's future promotional activities, including (where consented to) sending the entrant emails and/or text messages. Individuals have rights to access and request correction of their personal information held by Keep New Zealand Beautiful by calling 09 264 1434. Failure to provide all requested personal information may result in the entry being invalid.
  19. Each entrant agrees that, if he or she wins a prize, his or her details (including name, suburb/town, and photo and design) may be published by Keep New Zealand Beautiful (in any form eg: press, print, Facebook, website, Twitter etc) and used for other publicity purposes.
  20. All winners need to submit video footage and photos presenting their murals and the mural process.
